Rights of

In accordance with the provisions of article 7:08 of the Legislative Decree No 30 June 2003. 196, we inform you that you have the right:

1. to know the existence of personal data concerning you, to be placed at your disposal in an intelligible form;
2. to know the source of data on you;
3. to know the purposes and methods of treatment;
4. to know the logic applied in case of treatment with electronic instruments;
5. to know the details of the owner and managers of treatment;
6. to know the subjects or categories of persons to whom the information may be disclosed;
7. updating, rectification or integration of data that concern you;
8. the cancellation, transformation into anonymous form or blocking of personal data that concerns you, whose treatment had not been properly authorized;
9. to oppose, for legitimate reasons the processing of data pertinent to the purpose of collection;
10. to oppose the use of data provided for the purpose of sending advertising material or commercial information.
